Introduction

This privacy policy explains how COEL uses the information collected by this website. (www.coel.uk.com).

We gather and use information about visitors to our website in order to:

- Enable certain website functionality.
- Collect information to better understand how visitors use our website.
- Enable us to provide information relevant to our visitors.

Data Gathering

We may collect the following information:

- Contact information (e-mail, phone number, address etc.).
- Website usage data.
- Other relevant information in respect of visitor enquiries.

How We Use This Data

This data helps us understand what our website visitors are looking for and enables us to provide relevant, timely information.

We may use this data:

- For our own records.
- To improve the information and services we offer.
- To contact you in response to a query.
- To customise our website to enable a better user experience.

We will never contact you with unsolicited marketing or communications without your consent.

Cookie Use

A cookie is a small file placed on your computer's hard drive which enables our website to identify the pages you view. Cookies allow websites to store your preferences in order to present information relevant to you. They also enable us to analyse how many people visit our website and which pages



are visited most regularly (visit www.allaboutcookies.org for a longer description of what a cookie is).

Cookies CANNOT access information stored elsewhere on your computer or cause any harm. They are not programs or software and are simply a plain text file. They also cannot be accessed by any other website other than the one that created it.

You can control cookie usage via your web browser cookie settings. If you do not want our website to store cookies on your computer or devices you should set your web browser to refuse cookies. This may however affect how our website functions in terms of pages and services that are then available to you.

We may use cookies to:

- Analyse our web traffic using analytics software such as Google Analytics;
- Test the content on our website;
- Store information about your preferences to enable us to present relevant content when you visit us next time
